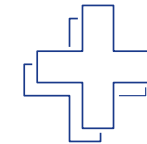
The fund's current investment process has been in place since 1990. In that time, the fund delivered a cumulative return of 1,433% versus 1,622% for the Russell 1000 Value Index and 1,100% for the Lipper peer group.¹

A cushion during market declines



The fund outperformed its benchmark and peers by an average of 7.54% and 1.72%, respectively, during downturns in 2001, 2002 and 2008.²

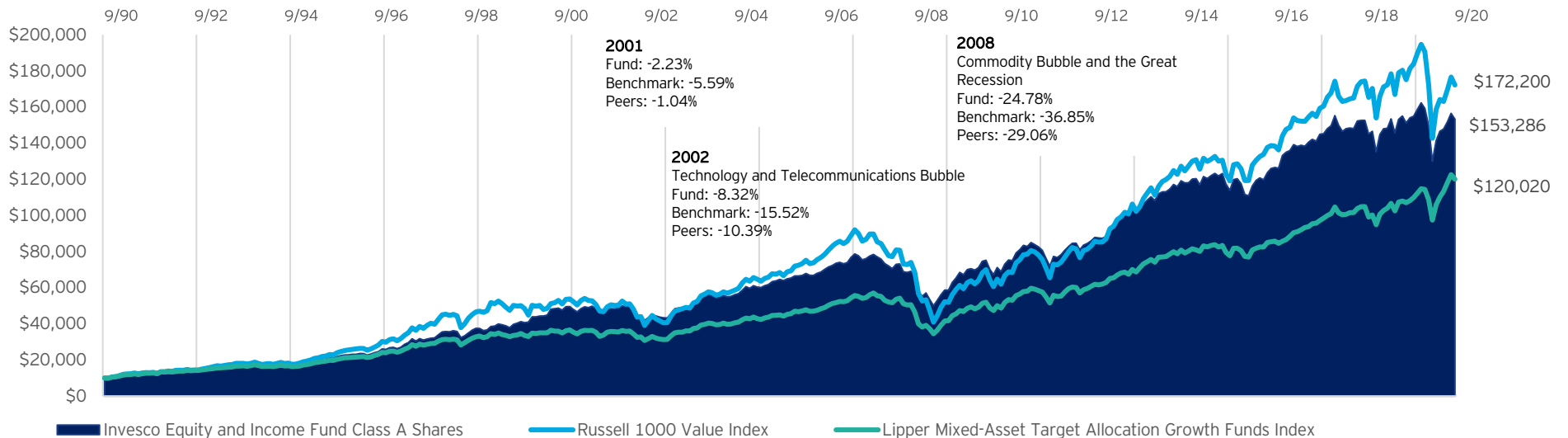
A potentially smoother ride
